Item Summary:

The City Council will consider and discuss the recall of Mayor Jerry Cain following the submission of a recall petition signed by registered voters of the City of Freeport requesting a recall election.

Background Information:

A recall petition has been submitted by registered voters of the City of Freeport seeking the recall of Mayor Jerry Cain. The petition alleges that Mayor Cain has violated his duties to the City and its citizens and has engaged in incompetency, misconduct, and malfeasance in the performance of his official duties as Mayor.

Pursuant to applicable law, upon receipt and verification of a valid recall petition, the City Council is required to take action to call a recall election.

Special Considerations:

If the recall petition is determined to meet statutory requirements, the City Council is required by law to adopt an ordinance calling a recall election for Mayor Jerry Cain in accordance with state and local election laws.

Financial Impact:

The City is currently involved in ongoing litigation that may result in significant financial exposure. Actions and conduct related to these matters may impact the City's legal position, insurance coverage, and defense costs. Potential financial impact to the City could reach



millions of dollars, including but not limited to litigation expenses, settlement or judgment amounts, and related costs.

PETITION FOR RECALL ELECTION OF
JERRY CAIN
MAYOR OF FREEPORT, TEXAS

TO THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

WE, the undersigned citizens of the City of Freeport, Texas and registered voters of the City of Freeport, Texas contained therein, do petition the City Council to call a RECALL ELECTION for the removal of, **JERRY CAIN**, holding the position of Mayor.

Such recall election is necessary, and the grounds of the petition are based upon incompetency, misconduct, or malfeasance, generally for supporting and encouraging financial corruption, actions to hide and cover up financial losses and misappropriations, failing to inform council of material items of concern, refusing or altering agenda requests of council members in violation of law, conspiring with the City Manager, Lance Petty to commit criminal and violent acts against a councilman, promoting risk of violence against a councilman by refusing and reducing security, failure to inform council about plans of violent criminal acts against a councilman, and additionally failing to report abuse of authority by City Manager, Lance Petty specifically set forth below:

1. Ex-City Manager **Lance Petty has sued the City of Freeport for OVER \$1 Million Dollars**. Cain volunteered to testify on Petty's behalf and aid his lawsuit against the City and the taxpayers. Cain **violated his oath** to Serve and Protect the City of Freeport's interest and his actions now jeopardize the City's legal position because of his help to Petty.
2. Jerry Cain was directly involved in the **Covarubias Construction Coverup** of the **unauthorized \$345K wire to Covarubias**. Cain took actions to **hide the illegal payment of \$345K from the City Council for over two months**. Today the City is still trying to recover the \$345K.
3. City Manager Petty informed Mayor Cain of his plan to physically assault Councilman Pena in a City Council meeting. **Petty's statements were recorded by the Police Chief Howell** and are not in dispute. After being informed of Petty's plans, Mayor Cain took the following actions:
 - a. **Ordered** the Police Chief to reduce and restrict police officer presence in city council meetings;
 - b. **Conspired** with Petty to provide the opportunity for Petty to assault Councilman Pena;
 - c. **Failed to Inform** Councilman Pena, or the city council of Petty's plans to commit **Criminal Conduct** against Councilman Pena; and
 - d. Failed to report **Insubordination** of City Manager Petty to the city council;

4. Cain **Failed to Inform** Councilman Pena, or the city council of Petty's plans to commit criminal conduct against Councilman Pena in the form of **Physical Assault, Kidnapping, and Murder.**
5. Cain cooperated and coordinated with Lance Petty to **hide evidence against Chief Howell** from being reviewed by the City Council and participated in the illegal suspension of Chief Howell allowing a potential employment liability lawsuit against the City.

Mayor Cain is a traitor to the taxpayers and citizens of the City of Freeport. He is helping the ex-city manager sue the City for over \$1 million dollars. He has betrayed the citizens to help his friend win a lawsuit. A lawsuit paid by the taxpayer. The above actions constitute misconduct and malfeasance. Removal of Mayor Cain through a Recall Election will demonstrate that the citizens of Freeport refuse to tolerate coverups, coordinated corruption with the (Ex) City Manager, and malfeasance to bring legal liability and expense to the City.
